Upon execution of a unanimous approval agreement by a participating property owner and completion of other applicable

program requirements, a special tax lien will be imposed on the participating property, and a special tax will be authorized to be levied, to be secured by that special tax lien, in the amount specified in the unanimous approval agreement. The special taxes on participating properties will be collected in the same manner as ordinary ad valorem property taxes are collected and will be subject to the same penalties and the same procedure, sale, and lien priority in case of delinquency as is provided for ad valorem property taxes, except that the City has reserved the right to enforce the collection of delinquent special taxes through judicial foreclosure, including the assignment of the ability to pursue judicial foreclosure as provided in the Act.
