SUMMARY OF RELIEF
Compliance Plan: Defendant School District must submit Compliance Reports four (4) times a year, on September 15, December 15, March 15, and a yearly annual report regarding a range of issues, such as the athletic opportunities offered to female students, the quality and quantity of uniforms, and the condition of athletic facilities such as the softball field. Class Counsel is permitted to conduct inspections of CPHS athletic facilities with prior notice and an Independent Expert will also assess girls' athletic facilities prior to the start of the season.
Training: Defendant School District must provide annual Title IX training for key staff and coaches to ensure they understand the law and how to ensure equity for female student athletes.
Athletic Opportunities: CPHS must provide female athletes with equal athletic participation opportunities. CPHS must offer: a novice softball team, a novice girls' soccer team, a girls' lacrosse team, a girls' golf team, a girls' field hockey team, girls' tennis, and girls' water polo. CPHS must maintain a written record of all girls' requests to participate in CPHS athletics (including requests to form new teams and additional team levels for existing teams) and the school's response. CPHS must conduct a survey of all female CPHS students regarding their interests in athletics. CPHS recruiting of female athletes must be comparable to recruiting of male athletes, including announcing athletic opportunities in the daily bulletin, outreach to girls at local middle schools who might participate in CPHS athletics, and publicly referring to wrestling, roller hockey, and football as co-ed sports to encourage girls to play these sports. CPHS must ensure that each head coach knows that he or she is responsible for recruiting. CPHS must ensure the head coach of each girls' sports team visits all P.E. classes to recruit for their team. CPHS must hold assemblies at CPHS to recruit girls to play sports prior to the start of each sports season. All recruiting efforts must be included in Compliance Reports.
Facilities: CPHS must maintain all female athletic facilities (including concessions) on an equal level with those provided to male athletes. CPHS must post maintenance schedules for the softball facility, in season and out of season. The CPHS varsity girls' softball facility must be dedicated to the girls' softball team and P.E. classes must not practice or compete on the girls' softball facility. Due to this lawsuit, Defendant constructed new cinderblock softball dugouts, a softball team room, a girls' athletic locker room, and softball batting cages and bullpens, among other improvements.
Uniforms, Equipment, Storage: CPHS must provide all female athletes with the same quality and quantity of sport-related equipment, practice apparel, and competition uniforms, instructional technology, and storage, as male athletes. CPHS must conduct inventories, remedy deficiencies and replace uniforms regularly and equitably.
Practice and Game Schedules: CPHS must provide all girls' athletic teams with equitable practice and competition schedules as compared to boys' athletic teams. CPHS must establish practice schedules no later than six (6) weeks before the beginning of each official sports season. CPHS must establish competition schedules no later than twenty-one (21) days before the beginning of the official sports season. CPHS must provide female athletes with equitable practice and competition schedules on preferred days and times (e.g., practice right after school, games on Friday nights at 7:00 p.m.). CPHS must rotate practice and game schedules to ensure girls' athletic teams have access to preferred athletic facilities and preferred practice and game times when girls' and boys' teams play in the same season and/or in the same facilities. Boys' athletic teams cannot cut into girls' athletic team practice times. Girls' athletic competitions cannot be cancelled because of a lack of coach. The Title IX Compliance Officer must review and approve practice and competition schedules four (4) weeks prior to the official sports season. CPHS must distribute final practice and competition schedules to all coaches no later than fourteen (14) days before the start of each official sports season. Coaches must provide players with practice and competition schedules on the first day after tryouts are completed and team members have been selected. CPHS must post final practice and competition schedules on CPHS's website.
Coaching: CPHS must recruit and provide girls' teams with coaches who have equal qualifications and experience as compared to coaches of boys' teams. Each girls' athletic team must have a head coach. CPHS will conduct regular coaching audits, remedy deficiencies and provide results in Compliance Reports.
Medical and Training Services: CPHS must make athletic trainers, physicians, physical therapists, rehabilitation services, and clinics equally available to girls' athletic teams. The Co-Ed Weight Training facility must be made available to female athletes on an equal basis with male athletes. CPHS must ensure that weight equipment provided meets female athletes' strength training needs. The Co-Ed Weight Training Facility sign must remain in place indefinitely. Female athletic teams must be permitted to reserve the Co-Ed Weight Training Facility on an equal basis with male athletic teams. Athletic teams must vacate the Co-Ed Weight Training Facility no later than the end of their scheduled conditioning time to avoid cutting into another team's use of the facility.
Publicity and Promotional Support: CPHS must ensure female athletic teams receive equitable publicity and promotional support, including cheerleaders and band. CPHS must provide printed schedules for girls' athletic teams equal to those provided for boys' teams (and in the same format and size). CPHS must acknowledge female athletes equally in the electronic marquee, daily bulletin, and online. CPHS must ensure that the yearbook equally covers girls' athletics. CPHS must equally provide scoreboards, scorekeepers, statistics gathering and videotaping to female athletic teams. CPHS must ensure banquets and awards are equal for female athletes as compared to male athletes.
Fundraising: CPHS must provide female athletes with equal opportunities to fundraise. If multiple athletic teams wish to lead a particular fundraiser, the opportunities must be rotated equitably between boys' and girls' athletic teams. CPHS must provide all coaches with training regarding fundraising and the Trojan Foundation.
Complaints: Defendant School District must maintain records of all complaints. Any student, parent, coach or teacher may report a complaint by email, mail, by telephone, or in person to the head coach, Athletic Director, Principal, or Compliance Staff. If the complaint is made about a sport during its season, an investigation must take place and the results of the investigation must be shared with the complainant in writing within five (5) school days (or ten (10) school days if the complaint is made outside the sports season). Complaints must be handled in a confidential manner.
Retaliation: Retaliation is prohibited against anyone making a Title IX complaint.
Miscellaneous: Defendant School District is responsible for the fees and costs related to monitoring Plan compliance.
Section 1983 Claim: At Class Counsels' request, the Court will dismiss the Plaintiffs' claim for relief under Section 1983.
