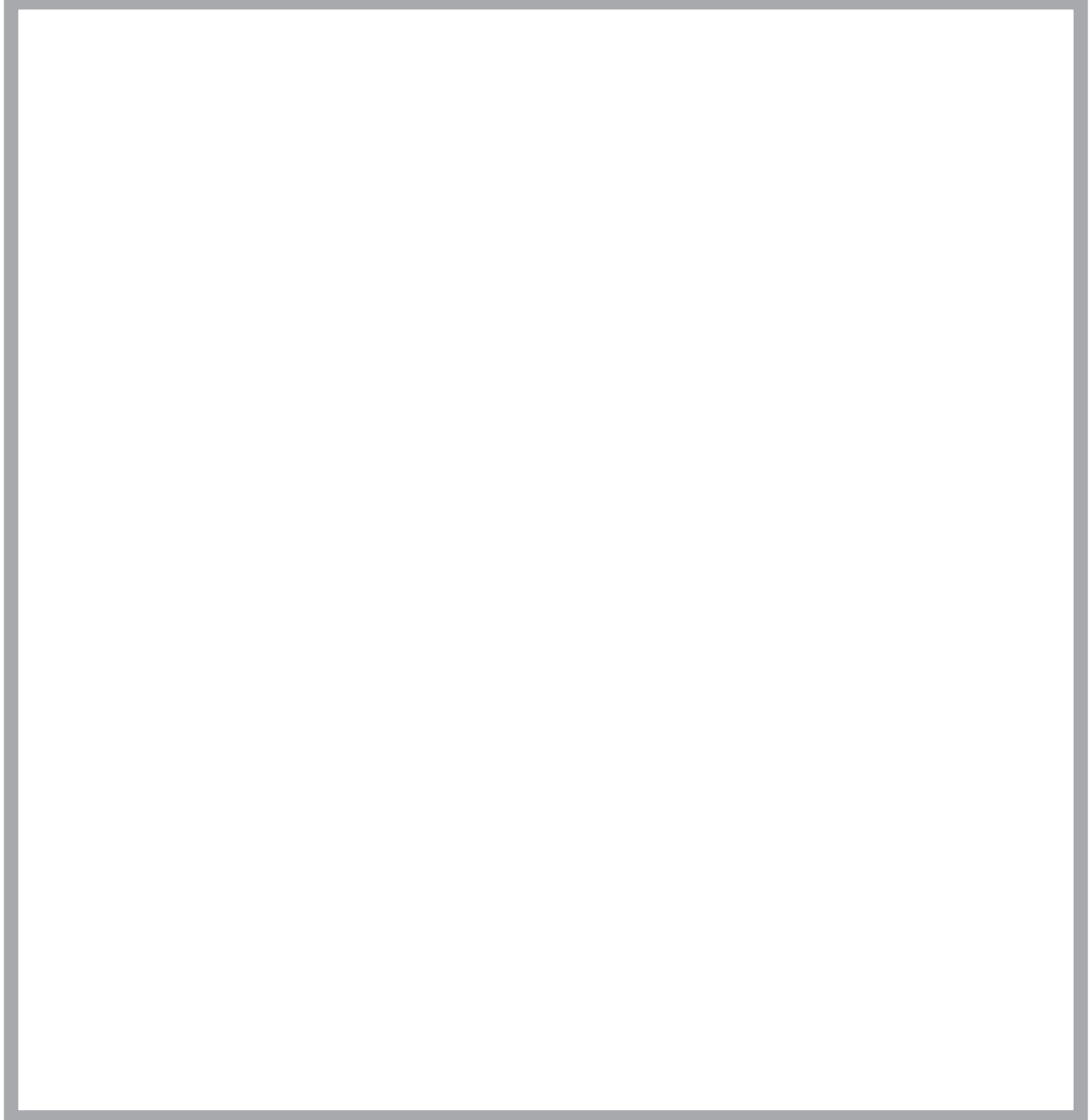

The Carriage House is a Historical Resource, identified by the 1985 Historical Resources Survey as Local Historic Site #17. The delisting will enable the Applicant to demolish the existing structure and build a new single-family dwelling and detached garage. The Applicant applied for a Certificate of Appropriateness (COA) as required by the Historic Preservation Ordinance. The Historic Preservation Commission will recommend their decision to the City Council as the final decision making body.

**ENVIRONMENTAL STATUS:** Development Services staff has reviewed the proposed delisting project for compliance with the California Environmental Quality Act (CEQA) and has determined that the project, although originally designated as an historical resource, no longer meets the eligibility criteria for a historical resource. Therefore, the project is not subject to CEQA Section 21084.1. The project is, therefore, exempt from CEQA review pursuant to CEQA Guidelines Section 15301(l)(1) Existing Facilities (Demolition of Small Structures), and no further CEQA review is required.

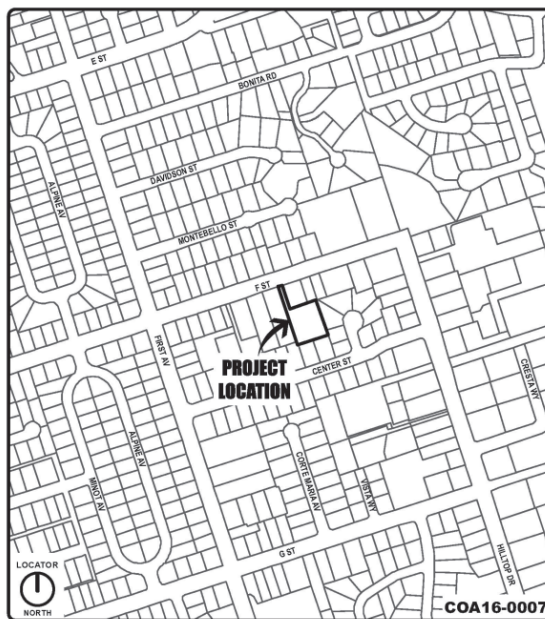
