

PROJECT DESCRIPTION: The Applicant is requesting to delist his property known as the Herman Hotel Carriage House from its historical designation. The Carriage House is a Historical Resource, identified by the 1985 Historical Resources Survey as Local Historic Site #17. The delisting will enable the Applicant to demolish the existing structure and build a new single-family dwelling and detached garage. The Applicant applied for a Certificate of Appropriateness (COA) as required by the Historic Preservation Ordinance. The Historic Preservation Commission will recommend their decision to the City Council as the final decision making body.

ENVIRONMENTAL STATUS: Development Services staff has reviewed the proposed delisting Project for compliance with the California Environmental Quality Act (CEQA) and has determined that the Carriage House, although originally designated as a local historical resource, no longer meets the eligibility criteria for a historical resource. New evidence demonstrates that the Carriage House's integrity has diminished, and that it was designated inaccurately as substantial structural alterations had changed its appearance, and it no longer physically conveys a historical significance. Furthermore, the Chula Vista Building Official and Fire Marshall have determined that building is unsafe and a potential threat to public safety. Therefore, the Project is not subject to CEQA Section 21084.1, and is therefore exempt from review pursuant to CEQA Guidelines Section 15301(I)(1) Existing Facilities (Demolition of Small Structures); no further CEQA review is required.


