**PROJECT DESCRIPTION**: The planning area for the OVRP is located in the southern portion of San Diego County four miles north of the interna-The OVRP will extend over 11 miles from the southeastern edge of the South Bay Wildlife Refuge through the Otay River Valley to the land surrounding the Otay Lakes area. The OVRP provides a recreational trail system experience for pedestrians, cyclists, and equestrians. The OVRP Concept Plan boundary encompasses approximately 9,000 acres. When the OVRP connects to the proposed Otay Ranch open space, this will provide a 19-mile open space corridor extending from San Diego Bay to State Route 94. Currently the OVRP has approximately 6,500 acres of public ownership. The Concept Plan will provide direction and guidance for parkland acquisition, development efforts, and the evaluation of proposals that may affect the OVRP.

ENVIRONMENTAL STATUS: The City of Chula Vista, as a responsible agency, and the County of San Diego as the lead agency, have found that the Concept Plan update qualifies for a Statutory Exemption pursuant to Section 15262 (Feasibility and Planning Studies) of the CEQA State Guidelines. The Concept Plan includes generalized trail citing criteria, and identifies proposed recreational elements. Prior to the development of any park improvements, detailed development plans will be prepared. During the preparation of plans for specific park improvement projects, project specific environmental review and the permitting process will commence. Additionally, the Concept Plan is a framework that does not propose to construct any physical facilities or improvement under subsequent Council action.
