DESCRIPTION OF SERVICES

The services that are authorized to be financed from the proceeds of special taxes levied within Improvement Area "C" are certain services which are in addition to those provided in or required for the territory within Improvement Area "C" and will not be replacing services already available. A general description of the services authorized to be financed by the District is as follows:
