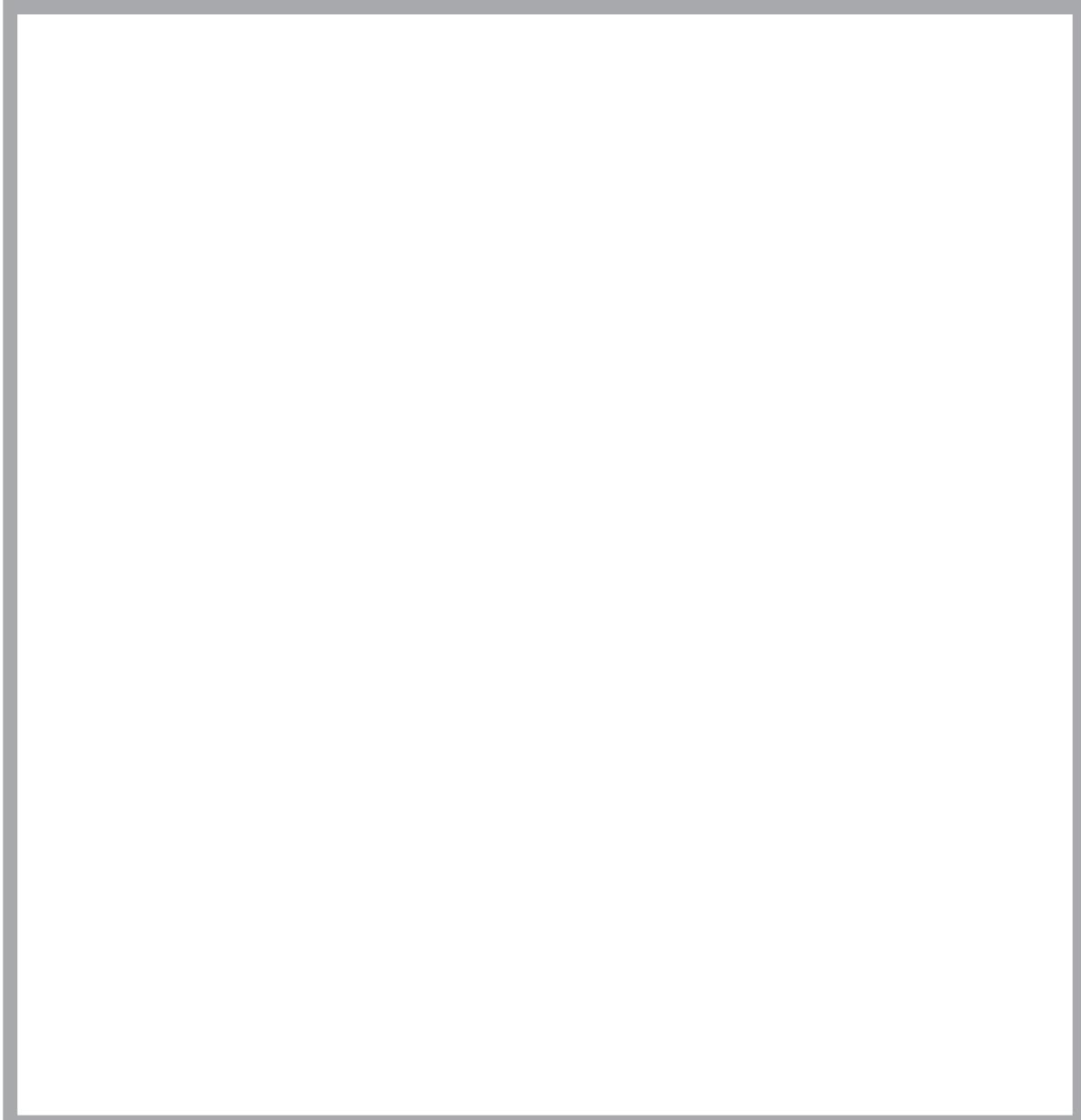

On or about October 3, 2015 the City of Chula Vista will submit a request to the Department of Housing and Urban Development for the release of HOME funds under Title I of the Housing and Community Development Act of 1974, as amended to undertake a project known as Milenia Affordable Housing project for the purpose of providing a total of 210 family and senior rental apartment units affordable to very low and low income households. All 210 units will be rented on a rent restricted basis to households whose income is at or below 50-60 percent (%) of the Area Median Income as determined by HUD. HUD HOME funds in the amount of \$800,000 will be used for the family housing portion of the project which consists of 87 apartments (25 one-bedroom (35 two-bedroom and 27 three-bedroom units) A total of 22,540 square feet of on-site open space will be provided.
