FORMING AND ESTABLISHING COMMUNITY FACILITIES DISTRICT NO. 18M (OTAY RANCH VILLAGE 3) AND AUTHORIZING THE LEVY OF A SPECIAL TAX THEREIN TO FINANCE CERTAIN SERVICES.

On October 4, 2016, the City Council (the "City Council") of the City of Chula Vista (the "City") adopted Resolution No. 2016-198 declaring its intention to consider the formation of proposed Community Facilities District No. 18M (Otay Ranch Village 3) ("CFD No. 18M") and setting a public hearing on said resolution of intention with respect to the formation of said community facilities district.

Resolution No. 2016-198 provides in summary as follows:

- 1. The name proposed for the community facilities district is "Community Facilities District No. 18M (Otay Ranch Village 3).'
- 2. The boundaries of CFD No. 18M are described and shown on the map entitled "Proposed Boundaries of Community Facilities District No. 18M (Otay Ranch Village 3), City of Chula Vista, County of San Diego, State of California," which is on file in the Office of the City Clerk (the "City Clerk").

3. It is the intention of this City Council to finance certain services authorized to be financed pursuant to the terms and provisions of the of the "Mello-Roos Community Facilities Act of 1982," being Chapter 2.5, Part 1, Division 2, Title 5 of the Government Code of the State of California (the "Act") and the City of Chula Vista Community Facilities District Ordinance enacted pursuant to the powers reserved by the City of Chula Vista under Sections 3, 5 and 7 of Article XI of the Constitution of the State of California (the "Ordinance") (the Act and the Ordinance may be referred to collectively as the "Community Facilities District Law"). A general description of the services to be provided is set forth in Exhibit A to Resolution No. 2016-198 (the "Services").

The Services are in addition to those provided in or required for the territory within CFD No. 18M.

4. Except where funds are otherwise available, a special tax sufficient to pay for the Services and related incidental expenses authorized by the Community Facilities District Law, secured by recordation of a continuing lien against all non-exempt real property in CFD No. 18M, will be levied annually within the boundaries of CFD No. 18M. For further particulars as to the rate and method of apportionment of the proposed special tax (the "Rate and Method of Apportionment") reference is made to Exhibit B to Resolution No. 2016-198, which sets forth in sufficient detail the method of apportionment to allow each landowner or resident within CFD No. 18M to clearly estimate the maximum amount that such person will have to pay for the Services.

The special taxes proposed, to the extent possible, shall be collected in the same manner as ad valorem property taxes or in such other manner as the City Council shall determine, including without limitation, direct billing of the affected property owners, and shall be subject to the same penalties, procedure, sale and lien priority in any case of delinquency as applicable for ad valorem taxes. Any special taxes that may not be collected on the County tax roll shall be collected through a direct billing procedure by the Treasurer of the City, acting for and on behalf of CFD No. 18M.

The special tax obligation for any parcel may not be prepaid.

5. If, following the public hearing, the City Council determines to establish CFD No. 18M and proposes to levy the special tax within CFD No. 18M, the City Council shall then submit the levy of the special taxes to the qualified electors of CFD No. 18M pursuant to Government Code Section 53326 through 53327.5 and the applicable provisions of the California Elections Code. If at least twelve (12) persons, who need not necessarily be the same twelve (12) persons, have been registered to vote within CFD No. 18M for each of the ninety (90) days preceding the close of the public hearing, the vote shall be by registered voters of CFD No. 18M, with each voter having one (1) vote. Otherwise, the vote shall be by the landowners of CFD No. 18M who were the owners of record at the close of the subject hearing, with each such landowner or the authorized representative thereof, having one (1) vote for each acre or portion of an acre of land owned within CFD No. 18M.

Future annexation proceedings may only be completed with the unanimous consent of the owner or owners of any parcel proposed for annexation.

A general description of the services to be provided is set forth in Exhibit A to Resolution No. 2016-200 (the "Authorized") Services"). The Authorized Services to be financed by the levy of special taxes to be levied on specific territory within the Future Annexation Area to be annexed to CFD No. 18M may include some or all of such Authorized Services or may include alternatives to the Authorized Services.

The Authorized Services shall to the maximum extent practicable, taking into account budgetary and operational demands of the City, be provided in common with CFD No. 18M and the Future Annexation Area.

The City Council finds that the Authorized Services are necessary to meet increased demands and needs placed upon the City as a result of development occurring within the boundaries of CFD No. 18M and the Future Annexation Area.

The cost of the payment of the Authorized Services includes certain Incidental Expenses as such term is defined in Government Code Section 53317(e) and may include, but not be limited to, all costs associated with the annexation of the Future Annexation Area to CFD No. 18M; the costs of collecting any special taxes; and costs otherwise incurred in order to carry out the authorized purposes of CFD No. 18M.

5. Except where funds are otherwise available, a special tax sufficient to finance the payment of the Authorized Services (the "Special Tax") for the territory of the Future Annexation Area upon the annexation of such territory to CFD No. 18M and related Incidental Expenses authorized by the Act, secured by recordation of a continuing lien against all non-exempt territory in the Future Annexation Area that annexes to CFD No. 18M, will be levied annually within the boundaries of such territory upon the annexation thereof to CFD No. 18M. The rate and method of apportionment of the proposed Special Tax (the "Rate and Method of Apportionment") to be levied on such parcels shall be as set forth in Exhibit B to Resolution No. 2016-200, which sets forth in sufficient detail the rate and method of apportionment of the Special Tax to allow each landowner or resident within the territory in the proposed Future Annexation Area to clearly estimate the maximum amount of the Special Tax that such person will have to pay upon the annexation of such territory to CFD No. 18M.

Notwithstanding the foregoing, if the actual cost of the Authorized Services applicable to any parcel within the proposed Future Annexation Area is higher or lower than the cost of the providing the Authorized Services applicable to the parcels within the existing CFD No. 18M, a higher or lower Special Tax may be levied on such parcel within the proposed Future Annexation Area subject to the unanimous approval and election of the owner or owners of such parcel. In any such circumstance, the Rate and Method of Apportionment may be revised to reflect the higher or lower Special Tax, as applicable.

The Special Tax, to the extent possible, shall be collected in the same manner as ad valorem property taxes or in such other manner as this City Council or its designee shall determine, including, without limitation, direct billing of the affected property owners, and shall be subject to the same penalties, procedure, sale and lien priority in any case of delinquency as applicable for ad valorem taxes. Any Special Tax that may not be collected on the County tax roll shall be collected through a direct billing procedure by the Treasurer of the City, acting for and on behalf of CFD No. 18M.

The Special Tax obligation for any parcel may not be prepaid.

Pursuant to Government Code Section 53340 and except as provided in Government Code Section 53317.3, properties of entities of the state, federal, and local governments shall be exempt from the levy of the Special Tax.
