The proceeds from the sale of the Bonds, if issued, are intended to be used to finance the development of 126 affordable units for low income seniors known as 'Millenia Senior" apartments (the "Project"). The Millenia Senior apartments will be located near the southwest corner of Birch Road and Eastlake Parkway within the Otay Ranch Millenia master planned community. The Project will be developed, owned and operated by Chelsea Investment Corporation (the "Developer").

The Bonds (if any are issued) will be issued in an aggregate principal amount not to exceed \$21,019,000. The Bonds may be issued in one or more series. The Bonds will not constitute a debt or obligation of the Authority, the City of Chula Vista, the State of California, or any other public body, or to be in any way payable from taxes or other public funds.

If the Bonds are issued, by law, at least 20 percent of the rental units in the Project are required to be available for occupancy by persons or families whose income does not exceed 50 percent of the median income for the San Diego, California Primary Metropolitan Statistical Area (the "Area"), or, alternatively, at least 40 percent of the rental units are required to be available for occupancy by persons or families whose income does not exceed 60 percent of the median income for the Area, in each case at affordable rents established by applicable State law. It is expected that the Authority will require that all but one of the units be made available to low income
