**PROJECT DESCRIPTION**: The proposed project consists of: 1) a 96 square foot addition by enclosing the rear side second floor balcony; 2) a 600 square foot detached accessory living quarters; 3) a 600 square foot detached 3-car garage in the rear yard; 4) replace existing window framing and exterior vinyl siding with wood framing to more closely resemble the original historic construction. In addition, the owner seeks to obtain permits for a previously constructed 104 square foot front porch deck.


