REGARDING ISSUANCE OF MULTIFAMILY  
HOUSING REVENUE BONDS

NOTICE IS HEREBY GIVEN that, at its regular meeting to be held at 5:00 p.m. on Tuesday, March 13, 2018, at the City Council Chambers of the City of Chula Vista, California (the "City") located at 276 Fourth Avenue, Chula Vista, California 91910, the City Council of the City of Chula Vista will conduct a public hearing as required by Section 147(f) of the Internal Revenue Code of 1986, as amended, at which it will hear and consider information concerning the issuance by the Housing Authority of the City of Chula Vista (the "Authority") of multifamily housing revenue bonds (the "Bonds") for two proposed residential developments. The proceeds from the sale of the Bonds, if issued, are intended to be used to finance the acquisition and rehabilitation of 18 existing affordable units known as "Trolley Terrace" apartments and 40 existing affordable units known as "Cordova Village" (the "Project"). Trolley Terrace apartments are located at 750 Ada Street in southwest Chula Vista. Cordova Village apartments are located at 1280 E J Street in eastern Chula Vista. The refinance and rehabilitation will improve the property and extend the term of the affordable rents. The Projects will be developed, owned and operated by Trolley Cordova, LP (the "Developer").

The Bonds (if any are issued) will be issued in an aggregate principal amount not to exceed \$7,000,000 for both Trolley Terrace and Cordova Village Apartments. The Bonds for the Projects may be issued in one or more series. The Bonds will not constitute a debt or obligation of the Authority, the City of Chula Vista, the State of California, or any other public body, or to be in any way payable from taxes or other public funds. If the Bonds are issued, by law, at least 20 percent of the rental units in each Project are required to be available for occupancy by persons or families whose income does not exceed 50 percent of the median income for the San Diego, California Primary Metropolitan Statistical Area (the "Area"), or, alternatively, at least 40 percent of the rental units are required to be available for occupancy by persons or families whose income does not exceed 60 percent of the median income for the Area, in each case at affordable rents established by applicable State law. It is expected that the Authority will require that all but one of the units in each of the Projects be made available to low income persons.

ALL PERSONS HAVING ANY INFORMATION RELEVANT TO THE PROPOSED ISSUANCE OF THE BONDS DESCRIBED ABOVE ARE HEREBY INVITED TO APPEAR AT THE TIME AND PLACE MENTIONED ABOVE TO PRESENT SUCH INFORMATION TO THE CITY COUNCIL.

If you wish to challenge the City's action on the matter in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence delivered to the City Clerk's Office at or prior to the public hearing.
