- Assessment District Boundaries: The boundaries of the Assessment District are as shown by the assessment diagram filed in the offices of the City Clerk, which map is made a part hereof by reference.
- 4. Annual Report: Reference is made to the Annual Report prepared by the consultant, on file with the Clerk, for a full and detailed description of the improvements, the boundaries of the Assessment District, and the proposed assessments upon assessable lots and parcels of land within the Assessment District.
- 5. Notice of Public Hearing: The Council hereby declares its intention to conduct a Public Hearing concerning the levy of assessments in accordance with Section 22629 of the Act. All objections to the assessment presented, if any, will be considered by the Council. The Public Hearing will be held on Tuesday, July 3, 2018 at 6:00 pm or as soon thereafter as is feasible in the Council Chambers located at 1243 National City Boulevard, National City, CA 91950.
