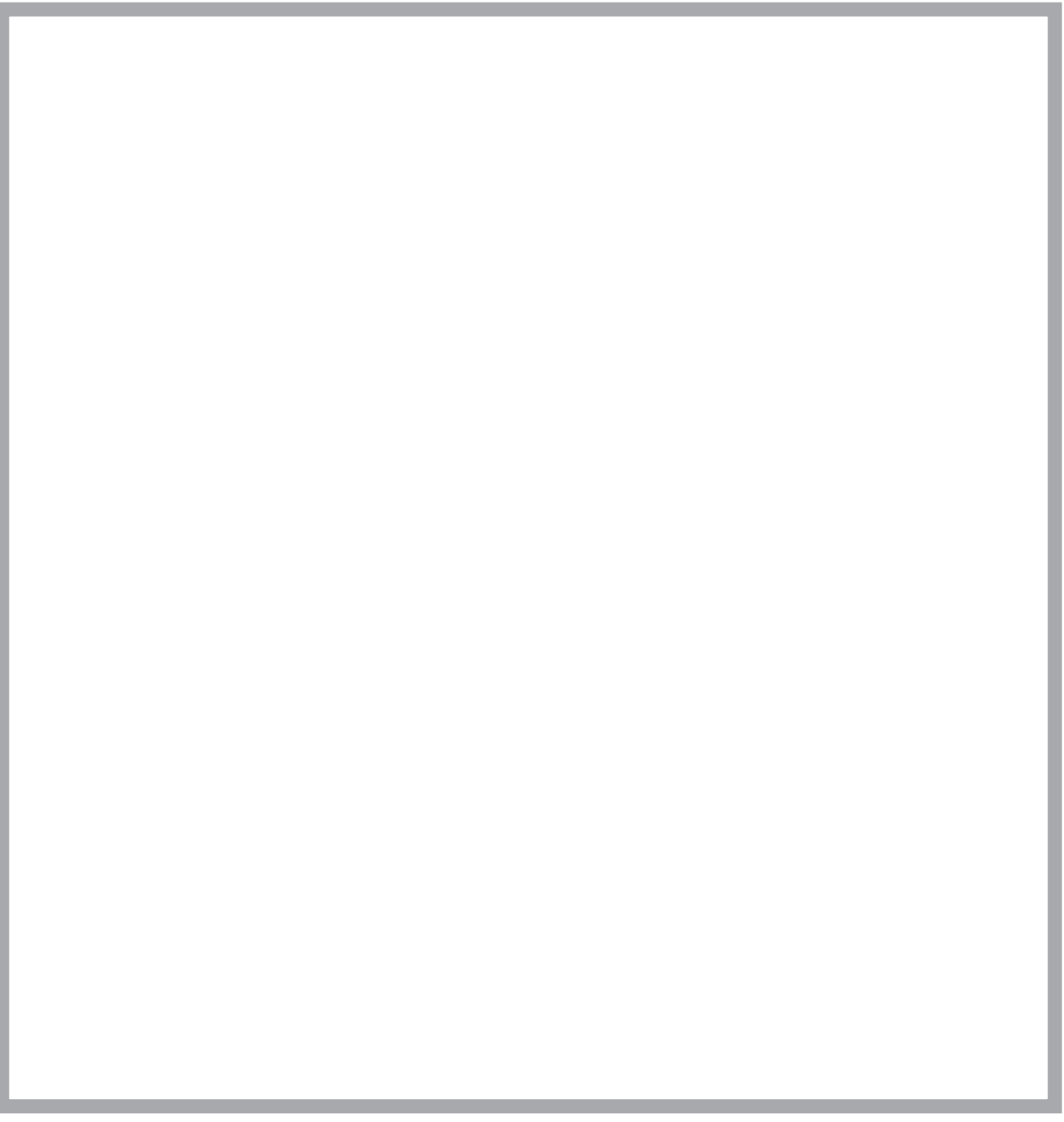

Project Description: The project would install and operate a ground-mounted 1.75 MWac solar photovoltaic power plant on approximately 16.9 acres of State-owned land within the R.J. Donovan State Prison. Project features include installation of single-axis trackers, installation of arrays providing approximately 6,048 solar panels, string inverters, underground conduits, and associated electrical equipment. The array field would be surrounded by a 20-foot-wide compacted native earth perimeter road and an 8-foot-high chain link fence. New fence installation would total about 3,320 linear feet. An underground generation-tie line would extend about 2,000 feet from the solar field to an existing 12-kV distribution power line along the southern edge of the prison.
