ORDINANCE NO. 3434 OF THE CITY OF CHULA VISTA ADDING CHAPTER 5.21, "CANNABIS BUSINESS TAX," TO TITLE 5 OF THE CHULA VISTA MUNICIPAL CODE TO ESTABLISH A TAX ON CANNABIS BUSINESS ACTIVITY

If approved by the voters at the November 6, 2018 election, Ordinance No. 3434 would impose a tax on cannabis business activity in the City ("Cannabis Tax"). The Cannabis Tax is a general tax which, if approved by a simple majority of the voters, can be spent for any lawful purpose of the city.

Ordinance No. 3434 was introduced on July 24, 2018 and adopted on August 7, 2018 by the following vote: AYES: Aguilar, Diaz, Padilla, and Salas; NOES: McCann; ABSENT: None; ABSTAIN: None.

ORDINANCE NO. 3435 OF THE CITY OF CHULA VISTA AMENDING VARIOUS CHAPTERS OF TITLE 2 OF THE CHULA VISTA MUNICIPAL CODE, RELATED TO REGULATIONS AND PROCESSES APPLICABLE TO THE CITY'S BOARDS AND COMMISSIONS

Ordinance No. 3435 revises regulations and processes related to the City's boards and commissions, removes redundant rules, simplifies language, and makes clarifications. In addition to other amendments, the ordinance (1) revises the appointment process for the Cultural Arts Commission, (2) removes the requirement for mandatory interviews prior to reappointment for certain commissions, (3) revises the number of members appointed to the Board of Appeals and Advisors ("BOAA") and adds as a duty the requirement the BOAA act as the hearing body for specified building-related appeals, and (4) revises the boundaries for specific seats on the Growth Management Oversight Commission to align with the City Council districts
