Ordinance No. 3440 consolidates the provisions of Chula Vista's three transportation develop-ment impact fees (the Transportation Development Impact Fee, and Western and Bayfront Development Impact Fees), from two separate areas in the Chula Vista Municipal Code into a single chapter, for the purposes of ensuring consistency between programs and simplifying administration. The consolidation also reflects minor modifications to improve readability; clarify application and administration of the fee programs; and updated fee waiver, reduction, and deferral provisions. There is no change to the fees in conjunction with this ordinance.

## SYNOPSIS OF MEASURE

Currently, there are no laws in the City of National City that control the amount of rent that a landlord may charge a tenant. Such laws are commonly known as "rent control" laws. If approved by a majority voté, this measure would enact a rent control ordinance providing for limits to be placed on the amount of rent that tenants in National City would pay. The proposed ordinance would apply only to residential rental units. However, the proposed ordinance would not apply to certain types of residential rental units, such as rental units in hotels or motels or in hospitals, extended care medical facilities, homes for the aged, dormitories, or rental units owned by certain types of non-profit organizations.

The proposed ordinance would create a Rent Board of five members. The members of the Rent Board would be appointed by the City Council, and would serve five-year terms. The Rent Board would pay for its costs of operation by charging landlords annual "Rental Housing Fees." The Rent Board would carry

The Rent Board would adopt and put into effect its own budget, and the City Council and City Manager would have no authority to oversee, supervise, or approve this budget. The Rent Board would have the authority to hire its own administrative and legal staff. Without approval of the City Council, the Rent Board could retain private attorneys to provide legal advice. The Rent Board would have sole and final authority to employ attorneys, legislative lobbyists, and other professionals.

A legal question exists as to the validity of the provisions granting the Rent Board the authority to adopt its own budget without the supervision or approval of the City Council and the City Manager, and to hire its own staff and employ attorneys and other professionals.

The ordinance would include "just cause for eviction protections", which would prohibit a landlord from taking action to terminate any tenancy except under certain circumstances, such as the tenant's failure to pay rent or violation of material terms of the rental agreement
