

(NCMC §10.70.020 (A.)) 2. Clear list of requirements for an applicant of a police regulated business

including, but not limited to, providing organizational documents for the business entity, the business license and permit history of the applicant, a copy of the applicant's driver's license and/or identification card used by a state or federal governmental agency, and the contact information for the owner of the property where the business will be located including a copy of the rental or lease agreement. (NCMC §10.70.030)

3. Specifically to massage businesses, an applicant must provide a list of all those employees who will administer massage, their dates of birth, full true name and any other names used, a copy of their massage practitioner certificates issued by the California Massage Therapy Council ("CAMTC"), as well as a copy of their driver's license or any other photo identification card issued by a State or Federal agency. Owners must also provide their CAMTC certificate, if any, and a statement that such certificate has not

been previously revoked or cancelled. (NCMC §10.70.030) 4. For massage businesses, fingerprints are required for an owner or operator only if they do not hold a valid massage practitioner certificate issued by the CAMTC. (NCMC §10.70.030) 5. Applicants must sign a statement and acknowledgment that the City can
