ORDINANCE NO. 3453 OF THE CITY OF CHULA VISTA AMENDING VARIOUS SEC-TIONS OF THE CHULA VISTA MUNICIPAL CONDUCT AND PENALTIES, INCLUDING CONDUCT AND PENALTIES, INCLUDING CVMC SECTIONS 1.04.010, DEFINITION OF RESPONSIBLE PARTY, 1.41.110, CIVIL PEN-ALTIES, 5.19.020, DEFINITIONS, AND 5.19.280, ENEODOCEMENT AND DEFINITIONS, AND 5.19.280, ENFORCEMENT AND PENALTIES

Ordinance No. 3453 amends Chula Vista Municipal Code (CVMC) sections 1.04.010, 1.41.110, 5.19.020 and 5.19.280 to clarify and improve the consistency of language regarding violations. Revisions include specification that violations of the commercial cannabis provisions in CVMC chapter 5.19 are exempt from the maximum \$2,500 civil penalty; reiteration that violations of CVMC chapter 5.19 are subject to a civil penalty of up to \$10,000 per violation per day, in accordance with CVMC section 5.19.280; amendments to clarify prohibitions and responsible parties when a violation occurs; and other clarifying and cleanup language.
