Beehives may only be kept on lots with a minimum area of ten thousand square feet within the open space and institutional zones and shall only be permitted on properties dedicated to agricultural or research use and shall be accessory to the primary use of the property. Examples in-clude, but are not limited to, farms, community gardens, schools, colleges or laboratories. They can no longer be located within a residential zone. The provision pertaining to a beekeeper applying for a beekeeping permit has been deleted and is no longer required.
