WHAT IS BEING PROPOSED?

The Department of Toxic Substances Control (DTSC) invites you to review and comment on a draft Removal Action Workplan (RAW) for the proposed Otay Ranch Village 3 Elementary School (Site), located in the northeastern corner of Camino Prado and Avenida Escaya in Chula Vista, California, 91913. The draft RAW describes the environmental studies that have been conducted at the Site and activities proposed to excavate soil impacted with arsenic.

The 8.3-acre Site was historically used for agriculture (dry farming) and cattle grazing and is located within an approximately 280-acre new housing development, referred to as Otay Ranch Village 3. The Otay Landfill is located approximately 1,100 feet northwest of the Site. As part of the school Site development, the Chula Vista Unified School District conducted an environmental assessment and recommended removal of elevated levels of arsenic impacted soil on the northeastern portion of the Site. The draft RAW proposes to remove approximately 1,958 cubic yards of arsenic impacted soil to a depth of 1.5 feet.

California Environmental Quality Act (CEQA) As a lead agency under CEQA, DTSC is required to evaluate and disclose significant environmental effects of a proposed project. DTSC prepared an Addendum to the City of Chula Vista's previously certified Final Environmental Impact Report (FEIR) for the Otay Ranch University Villages Project (State Clearinghouse No. 2013071077). The Addendum incorporates the proposed cleanup activities from the draft RAW that were not identified in the FEIR. DTSC determined that the draft RAW cleanup activities will not have a significant adverse impact on the environment.

DTSC encourages you to comment on the draft RAW. Before making a final decision on the draft RAW, DTSC will consider and respond to all public comments. A Response to Comments document will be sent to everyone who submitted a comment or requests a copy. A copy of the Response to Comments will also be available on DTSC's EnviroStor database.
