ORDINANCE NO. 3495 OF THE CITY OF CHULA VISTA AMENDING CHAPTER 15.26 OF THE CHULA VISTA MUNICIPAL CODE TO ES-TABLISH ENERGY UPGRADE REQUIRE-MENTS FOR ADDITIONS AND REMODELS TO SINGLE FAMILY HOMES AND CONDOS

Ordinance No. 3495 amends the Chula Vista Municipal Code Chapter 15.26 to add mandatory en-ergy efficient requirements for additions to single family homes and condos.

ORDINANCE NO. 3496 OF THE CITY OF CHULA VISTA AMENDING CHULA VISTA MU-NICIPAL CODE SECTION 2.05.010 ADDING THE UNCLASSIFIED POSITION TITLE OF HU MAN RESOURCES MANAGER AND DELET-ING THE HUMAN RESOURCES OPERATIONS MANAGER AND PERFORMANCE AND OR GANIZATIONAL DEVELOPMENT MANAGER POSITION TITLES

Ordinance No. 3496 amends the Chula Vista Municipal Code section 2.050.010 to add the unclassified position title of Human Resources Manager and to delete the unclassified position titles of Human Resources Operations Manager and Performance and Organizational Development Manager.

The ordinances were introduced on November 17. 2020 and adopted on December 3. 2020 by the following vote:
