SUMMARY OF PROPOSED ORDINANCE **ESTABLISHING THE COMPENSATION OF** THE MAYOR AND CITY COUNCIL

CITY OF NATIONAL CITY

NOTICE IS HEREBY GIVEN THAT at their regular meeting held December 15, 2020, the City Council of the City of National City introduced a proposed ordinance for first reading, which, if adopted, establishes the compensation of the Mayor and City Council.

The last salary adjustment for the Mayor and City Council occurred on February 21, 2017, with Ordinance No. 2017-2431. That Ordinance set the base salary of the City Council at \$1,189.78 per month and set the base salary of the Mayor at \$4.532.13.

According to Government Code Section 36516(a)(4), by ordinance, the Council may increase its compensation by 5% each calendar year from the date of the last salary increase. Additionally Government Code Section 36516.1 states that an elected mayor may receive compensation in addition to that which he or she receives as a councilmember, pursuant to an ordinance or by a vote of the electors at a municipal election.

During the December 15, 2020, regular meeting, the City Council voted to amend the proposed ordinance and reduce the compensation increase amount from 20% to 10%. Accordingly, the amended proposed ordinance reflects a 10% increase in the City Council's salary amounting to \$118.97, for a total of \$1,308.76 per month and in the salary of the Mayor amounting to \$453.21, for a total monthly amount of \$4,985.35.

The City Council of the City of National City will have the second reading of this ordinance. They will consider its adoption at the regular meeting to be held on January 19, 2021, at 6:00 p.m. in the National City Council Chamber, 1243 National City Boulevard, National City, California.. Meetings are currently via Zoom per the Governor's Executive Order.
