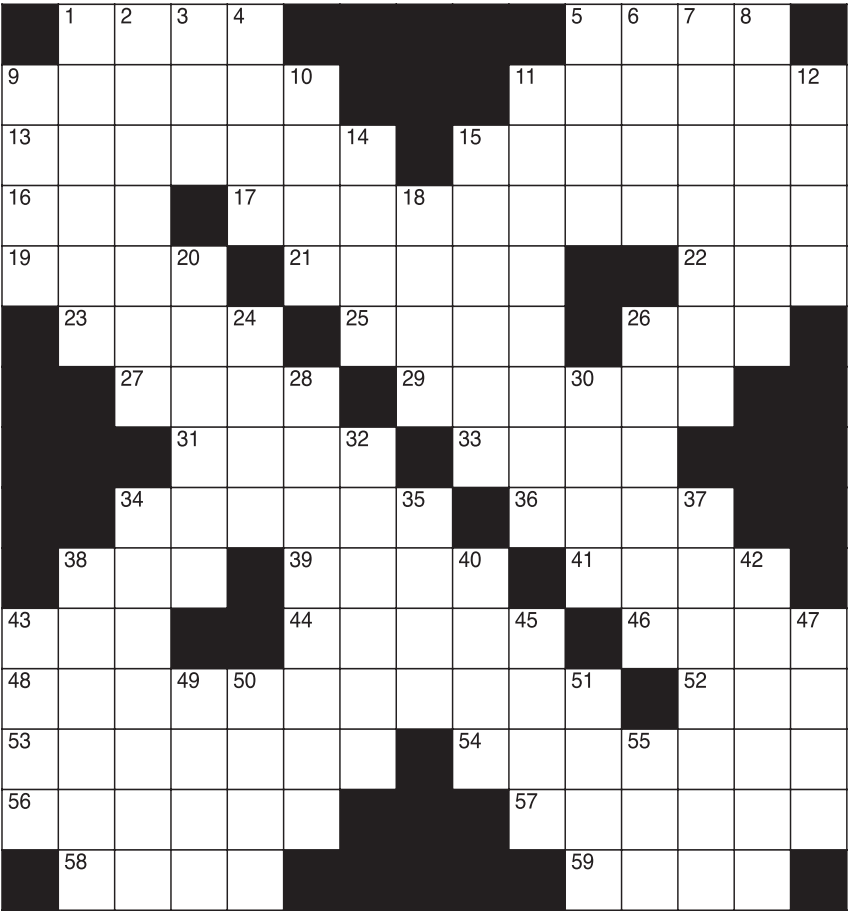

MERCURY’ RETROGRADES – A  
MAGICAL MYSTERY TOUR

Mercury begins its three-week retrograde journey Saturday, May 29th and continues in reverse ‘til June 22nd, moving from 25 to 16 degrees Gemini.

It’s good to consider Mercury retrograde as an alchemical span of time when self-reflection, introspection, the ability to understand the past (since last Mercury retrograde) occurs.
