NEW MOON, LUNAR ECLIPSE, BELTANE (BRILLIANT FIRE)

Pluto retrogrades Friday, April 29th. Retrogrades are times of contemplation, reflection, assessment of the past. With Pluto retrograde we consider issues such as power, creation, sex, death, renewal, rebirth and things hidden and unseen and mysterious. We all become Persephone (till October 8, 2022).

Saturday is a new moon solar eclipse (something essential falls away, its work complete) at 10 degrees Taurus. At new moon times the New Group of World Servers (NGWS) supports and uplifts the endeavors of the women and men of Goodwill everywhere. Flowers

Sometimes loose flowers were strewn about dairy floors or made into garlands, placed around cows and milking and butter-making equipment. The yellow flowers evoked the golden fire of the Sun. Beltane tells us summer's halfway here!
