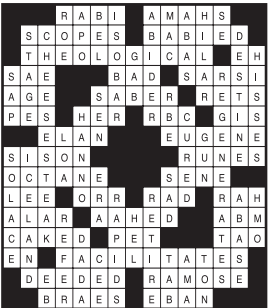

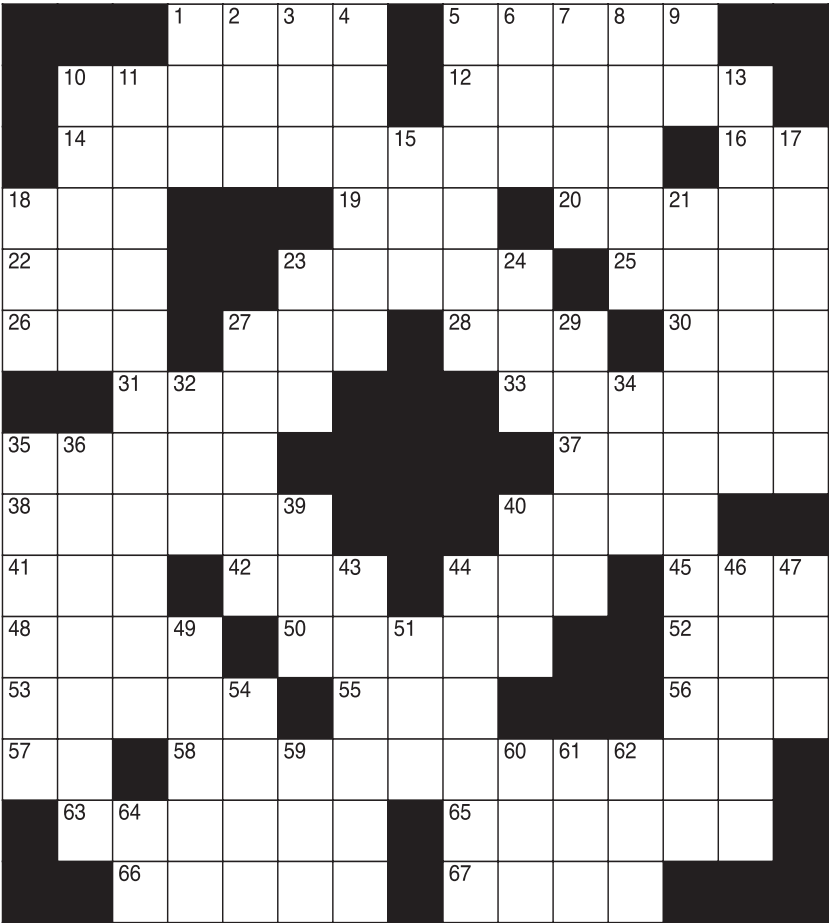

ENTERING A RETROGRADE
SEASON -
