Notice is hereby given that the City of National City (City), as the lead agency, is proposing to adopt a Mitigated Negative Declaration (MND) in accordance with the California Environmental Quality Act (CEQA) for the proposed project as identified below. A 30-day public review and comment period has been established pursuant to California Environmental Quality Act (CEQA) Guidelines Section 15073

for the Draft MND which has been prepared for the proposed project.

The applicant, USD Clean Fuels (USD-CF), proposes to construct a fuel transfer facility on the BNSF Railway railroad right-of-way (ROW) located between the existing buildings along Cleveland Avenue and the existing BNSF Railway tracks and between Civic Center Drive and W. 19th Street in National City, California. The new San Diego Clean Fuels Terminal will add nine rail spurs and four fixed truck loading spots to transfer bio-diesel fuel, renewable diesel fuel, ethanol and sustainable aviation fuel directly from rail cars into trucks. Trucks will be loaded with either renewable diesel fuel, a combina-tion of renewable diesel fuel and up to 20-percent bio-diesel fuel, ethanol or sustainable aviation fuel. The fuel will then be delivered via truck to local retailers within a 35-mile radius. Each truck loading spot will consist of a pump skid, controls and piping between the belly of the rail cars and the bottom loading port of the truck. Small amounts of lubricity, conductivity and red dye will be added in-line in the fuel transfer process depending on the order. Each spot also provides a concrete pad and drain

for containment of potential spills which will be piped to a containment basin on site. Plastics Express (PEX, a commercial partner of USD-CF), will operate the facility. A total of 12 employees will work at the site. The terminal will operate 24 hours per day, seven days per week. The employees support a schedule of three people per shift on three 8-hour shifts. A trailer will be provided as an office onsite and will incorporate the control center for the equipment, restrooms, and

an area for driver check-in and receipt of their bill of lading.

Rail cars will be delivered to the terminal be BNSF Railway and placed on designated receiving tracks. Once rail cars have been delivered to the terminal by BNSF Railway, the cars will be switched and spotted for fuel transfer by PEX. Once emptied, cars will be switched to designated departure tracks where BNSF Railway will remove cars as needed.

After completing the quality and quantity assurance requirements of product in each rail car, terminal personnel will unload the fuels directly form the rail cars into trucks via short above ground manifold. A percentage of tanker trucks coming to the facility may be 'wet tankers', trucks having recently hauled other fuels without having been cleaned. The rail car and truck unloading area will be equipped with a containment system capable of containing the contents of 110 percent of an entire rail car volume. In addition, and Emergency Response Plan (ERP) will be developed and implemen-

ted, to address and/or manage potential spills or emergency events onsite.

Truck traffic will enter the site from 18th Street and exit on W. 19th Street and on to their retail client deliveries. A second rail line will be added at the existing grade crossing on Civic Center Drive to facilitate rail car movements.

The Proposed Project consists of the following improvements: · Build tracks and turnouts/crossovers to facilitate car movement in/out and within the fuel transfer fa-

- Install concrete slab pump pads at each fuel transfer spot.
- Install truck load slabs sloped to drain in the center at each fuel transfer location.
   Install pumps and piping to move fuels from rail cars to truck loading locations.

Provide containment enclosures for fuel additives. • Provide a concrete-lined containment basin a pipe each load slab drain to the basin.

- Provide track pans for containment at the rail fuel transfer cars.
- Provide an office trailer with control center, restrooms and driver check-in area.

 Provide all weather paving for the facility and circulation. Provide lighting for the site as needed.

The terminal is expected to receive approximately 115 trucks per day via W. 18th Street and exiting the facility on W. 19th Street. Approximately 70-percent of truck trips will occur between 6:00 p.m. and 6:00 a.m. to avoid peak traffic periods.

An Environmental Initial Study (IS) was conducted that determined that although the proposed project could have a significant effect on the environment, there will not be a significant effect in this case because revisions in the project have been made by or agreed to by the project proponent.
