Title: Initiative Measure to Limit Compensation for Certain Healthcare Employees

Summary: This initiative would adopt an ordinance limiting the annual salaries of certain healthcare employees in the City of Chula Vista. A summary of its provisions is provided below.

Annual Compensation Limit. This measure proposes adopting an ordinance limiting compensation paid to certain employees of covered healthcare facilities in the City, pursuant to the following formula: 15 x applicable minimum wage x 2,080 hours = maximum annual compens-

Covered Employees and Facilities. The compensation limitation would apply to employees whose primary duties are executive, managerial, or administrative, and who work in any of the following facilities located in Chula Vista: licensed general acute care and acute psychiatric hospitals; outpatient clinics of general acute care or acute psychiatric hospitals; and other work sites that are part of an integrated health care delivery system of related hospitals and physician groups, or others providing or supporting health care.

**Applicable Compensation.** All payments from covered facilities to covered employees, whether through payroll or contract, would count toward the maximum compensation limit, even if made by separate entities. Compensation subject to the limitation would include all wages and the cash value of all benefits paid, earned, or accrued during the year, except certain Employee Retirement Income Security Act payments, or as otherwise preempted by state or federal law. Compensation from other entities not identified in the ordinance could constitute a violation of the ordinance if it is unreasonably disproportionate to its purpose, or designed to evade the ordinance's limitations.

Records Maintenance and Audits. The ordinance would require covered healthcare facilities to maintain compensation records for four years and to file annual reports documenting compliance with the ordinance. It would also authorize the City Attorney to conduct compliance audits. Employees receiving compensation over the maximum would be required to refund the excess amount, plus an additional 10% in in-

Penalties and Enforcement. Persons violating the ordinance could be liable for up to \$1,000 per day per violation, and an additional \$1,000 per day for willful violations. Covered facilities could also be liable for up to \$1.000 per day for delinguent reports. Actions to enforce the ordinance could be brought by the City Attorney, an aggrieved person or entity, or a person or entity acting on behalf of the public. Relief could include penalties, interest, attorneys' fees, and a refund up to twice the amount paid above the compensation limit. The City would be required to set aside funds to enable the City Attorney to implement and enforce the ordinance.

Title: Initiative Measure to Establish a Minimum Wage for Certain Healthcare Employees

Summary: This initiative would adopt an ordinance setting a minimum wage for certain healthcare employees in the City of Chula Vista. A summary of its provisions is provided below.

Minimum Wage. This measure proposes setting a minimum wage of \$25 per hour, with annual adjustments based on the specified Consumer Price Index, for covered employees at healthcare facilities in the

Covered Employees and Facilities. The ordinance would require the minimum wage be paid to employees who provide patient care, healthcare services, or support the provision of healthcare at the following facilities in the City: licensed general acute care and acute psychiatric hospitals; outpatient clinics of general acute care hospitals or acute psychiatric hospitals; community clinics, including primary care clinics and chronic dialysis clinics; federally qualified health centers; and other work sites that are part of an integrated health care delivery system of related hospitals and physician groups, or others providing or supporting health care. Covered employees would include: clinicians, professionals, non-professionals, nurses, certified nursing assistants, aides technicians, maintenance workers, janitorial and housekeeping staff persons, groundskeepers, guards, food service workers, laundry workers, pharmacists, administrative workers, and business office clerical

Employer Funding and Records Obligations. The ordinance would prohibit employers from funding minimum wage increases through reduced premium pay rates or shift differentials, reduced non-wage benefits, reduced work hours, lay-offs, or increased charges to covered employees. It would also prohibit retaliation by an employer against covered employees for enforcing, asserting their rights under, or opposing practices prohibited by, the ordinance. Employers would be required to post notice of the minimum wage required by the ordinance and to retain payroll records for a minimum of four years.

Penalties and Enforcement. The City would be responsible for enforcing the ordinance and would be required to: establish processes to report violations of the ordinance, investigate complaints, and issue administrative citations; take appropriate enforcement action on behalf of covered workers to collect and disburse amounts owed to them: and conduct education and other activities to ensure ordinance compliance. The ordinance would authorize the City Attorney, a covered employee or another person acting on behalf of the public, to bring a civil action against an employer violating the ordinance. Available remedies under the ordinance would include injunctive relief, reinstatement, payment of wages due, penalties up to \$120 per day, recovery of attorneys' fees and costs, and, for retaliation, reinstatement and treble the wages

Additional Provisions. The ordinance would prohibit employees from waiving their rights under the ordinance and would not limit other relief available to employees. It would allow a court to grant a one-year waiver of the minimum wage requirements to an employer if compliance would raise substantial doubt about the employer's ability to continue in business


