Otherwise, the vote shall be by the owners of the land within the Annexation Territory, with each landowner having 1 vote per acre (or portion of acre) of Annexation Territory owned by the landowner and not exempt from the special tay. ### **SUMMARY OF RESOLUTION NO. 4903**

The Board previously adopted Resolution No. 2639 to form CFD No. 10 in accordance with the Mello-Roos Act and to authorize the levy of a special tax within CFD No. 10 for the purposes of financing certain public facilities, as described in Resolution No. 2619, in Resolution No. 2639, and in the CFD Report for CFD No. 10. Although the Board established CFD No. 10 with reference to specific property located within the District's boundaries, the Board formed CFD No. 10 with the intent that additional territory may from time to time be annexed into CFD No. 10.

On January 24, 1998, a special election was held within CFD No. 10, in which the eligible voters ap-On January 24, 1998, a special election was neid within CFD No. 10, in which the eligible voters approved: (i) the levy of special taxes in accordance with the "Rate and Method of Apportionment of Special Tax – Community Facilities District No. 10 – Sweetwater Union High School District" ("RMA"); and (ii) the incurring of bonded indebtedness. On March 19, 1998, the Board, acting as the Legislative Body of CFD No. 10, duly adopted Ordinance No. 11 of CFD No. 10 to thereby authorize the levy of the special taxes.

The Board, acting as the Legislative Body of CFD No. 10, has determined that public convenience and necessity require that Annexation Territory be annexed into CFD No. 10 in accordance with the provisions of the Mello-Roos Act, thereby becoming subject to the special taxes of CFD No. 10, and the Board hereby states its intention to complete Annexation No. 22.

The Board intends that, following the completion of the Annexation No. 22 proceedings, the District, on behalf of CFD No. 10, shall levy the special taxes within the Annexation Territory in order to pay costs of, as applicable, the construction, expansion, rehabilitation or purchase of school facilities consisting of high school facilities or increments thereof, including land acquisition, appurtenances, furnishings and equipment, to serve needs created by development within the boundaries of the District. The RMA and procedure for levy of the special tax proposed for Annexation No. 22 to pay for CFD Facilities and services is the same as the RMA and procedure for levy of the special tax levied within existing CFD No. 10. Annexation No. 22 shall not result in any alteration of existing special tax rates within the boundaries of existing CFD No. 10.

At the time and place set forth above for the Public Hearing, the Board shall receive testimony for and against proposed Annexation No. 22 or regarding the levying of the special taxes within the Annexation Territory. Any interested person, including all persons owning land or registered to vote within the Annexation Territory, may appear and be heard. Any protest pertaining to the regularity or sufficiency of the proceedings shall be in writing and shall clearly set forth the irregularities or defects to which the objection is made. All written protests shall be filed with the Clerk of the Board prior to the Public Hearing. Written protests may be withdrawn in writing at any time before the conclusion of the Public


