Chapter 9.38 - TO-BACCO RETAILER LI-CENSE AND RE-STRICTING THE SALE, DISPLAY AND PROMOTION OF TO-BACCO TO YOUTH.

Section 9.38.010 Purpose and intent.

It is the intent of the City Council, in enacting this ordinance, to ensure compliance with the business standards and practices of the City and to encourage responsible tobacco retailing and to discourage violations of tobacco-related laws especially those which prohibit or discourage the sale or distribution of tobacco products to youth, but not to expand or reduce the degree to which the acts regulated by federal or state law are criminally proscribed or to alter the penalties provided therein. Accordingly, the City Council enacts the following regulations as not preemp ted by the Federal Cigarette Labeling and Advertising Act, U.S. Code sec. 1332, et seq.

Section 9.38.020 Definitions.

For purposes of this chapter:

A. "Arm's Length Transaction" means a sale in good faith and for valuable consideration that reflects the fair market value in the open market between two informed and willing parties, neither of which is under any compulsion to participate in the transaction. A sale between relatives, related companies or partners, or a sale for which a significant purpose is avoiding the effect of the violations of this chapter is not an Arm's Length Transaction.

"Applicant" means the Person applying for a permit pursuant to

"Cigarette" means: (1) any roll of tobacco wrapped in paper or in any substance not containing tobacco; and (2) any roll of tobacco wrapped in any substance containing tobacco which, because of its appearance, the type of tobacco used in the filler, or its packaging and labeling, is likely to be offered to. or purchased by, consumers as a cigarette described herein

"City" means City of National City, Califor-

J. "Compliance checks" means systems the department uses to investigate and ensure that tobacco retailers are following and complying with the requirements of this chapter. Compliance checks may involve the use of persons between the ages of 18 and 20 who purchase or attempt to purchase tobacco products. Compliance checks may also be conducted by the department or other units of government for educational, research, and training purposes or for investigating or enfor-cing federal, state, or local laws and regulations relating to to-bacco products.

K. "Coupon" means any voucher, rebate, card, paper, note, form, statement, ticket, image, or other issue, whether in paper, digital, or other form, used for commercial purposes to obtain an artcle, product, service, or accommodation without charge or at a discounted price.

means the sale of any tobacco product to any person for personal consumption and not for resale when the sale is conducted by any means other than an in-person, over-the-counter sales transaction in a tobacco retail establishment. O. "Flavored Tobacco Product" means any tobacco product that imparts:

a taste or odor distinguishable by an or-dinary consumer, other than the taste or odor of tobacco, either prior to or during the consumption of such tobacco product, including but not limited to tastes or odors relating to any fruit, chocolate, vanilla, honey candy, cocoa, dessert alcoholic beverage mint, wintergreen menthol, herb, or spice

2. a cooling or numbing sensation distinguishable by an ordinary consumer during the consumption of such tobacco product

P "Full Retail Price" means the displayed price plus all applicable taxes and fees if such taxes and fees are not included in the displayed price. For the purposes of this chapter, "Displayed Price" means the price displayed for a tobacco product on its packaging or on any related shelving, advertising, or display where the tobacco product is sold or offered for sale.

Q. "Little Cigar" means any roll of tobacco other than a cigarette wrapped entirely or in part in tobacco or any substance containing tobacco and weighing no more than 4.5 pounds per thousand Little Cigar includes but is not limited to, tobacco products known or labeled as small cigar, little cigar, or cigar-

"Manufacturer" means any person, in-cluding any repacker or relabeler, who manu-factures, fabricates, assembles, processes, or labels a tobacco product, or imports a finished tobacco product for sale or distribution into the United

S. "Moveable Place of Business" means any

form of business that is operated out of a kiosk truck, van, automobile or other type of vehicle or transportable shelter and not a fixed address store front or other permanent type of structure authorized for sales transactions.

T. "Person" means any human being, partner ship, cooperative association, corporation personal representative, receiver, trustee assignee, or any other legal entity.

U. "Pharmacy" means any retail establishment in which the profession of pharmacy is practice by a pharmacist licensed by the State of California in accordance with the Business and Professions Code and where prescription pharmaceuticals are offered for sale, regardless o whether the retail establishment sells other retail goods in addition to prescription pharmaceuticals.

V. "Proprietor" means a person with an ownership or managerial interest in a business. Ar ownership interest shal be deemed to exist when a person has a 10% or greater interest in the stock, assets, or income of a business other than the sole interest of security for debt. A managerial interest shall be deemed to exist when a person has or shares ultimate control over the day-today operations of a business.

W. "Recreation Facility" means an area, place structure, or other facility that is used either permanently or temporarily for community recreation, even though it may be used for other purposes, and includes but is not limited to, a gymnasium playing court, playing field, and swimming pool.

X. "Sale" means any transfer, exchange barter, gift, offer for sale, or distribution for a commercial purpose in any manner or by any means whatsoever.

Y. "Self-Service Display" means the oper display or storage of tobacco products in a manner that is physically accessible in any way to the general pub-lic without the assistance of the retailer or employee of the retailer and a direct face-toface transfer betweer the purchaser and the retailer or employee of the retailer. A vending machine is a form of Self-Service Display.

"Smoking" means inhaling, exhaling, burning, or carrying any lighted or heated cigar cigarette, or pipe, or any other lighted or heated product containing, made, or derived from nicotine, tobacco, marijuana, or other plant, whether natural or synthetic that is intended for in-halation "Smoking" includes using an electronic smoking device

AA. "Tobacco Product' means:
1. Any product contain-

ing, made of, or derived from tobacco or nicotine that is intended for human consumption or is likely to be consumed, whether

CC "Tobacco Retailing" means engaging in the activities of a tobacco retailer.

DD. "Youth-Oriented Facility" means a parcel in the city that is occupied by: 1. a private or public kindergarten, element-

ary, middle, junior high, or high school;
2. a library open to the

public; 3. a playground open to the public;

4. a youth center defined as a facility where children, ages 6 to 17, inclusive, come together for programs and activities;

5. a recreation facility open to the public, defined as an area place, structure, or other facility that is used either permanently or temporarily for community recreation, even though it may be used for other purposes;

6. a park open to the public or to all the residents of a private community;

7. a licensed child-care facility or preschool (other than a smallfamily day care home or a large-family day care home [as defined in California Health & Safety Co 1596.78]). Code

A. Tobacco retailer's li-cense required. It shall be unlawful for any person to engage in to-bacco retailing in the City without first obtaining and maintaining a valid tobacco retailer's license for each location at which tobacco retailing is to occur.

B. Lawful business operation. In the course of tobacco retailing or in the operation of the business or maintenance of the location for which a license issued it shall be a violation of this chapter for a licensee, or any of the licensee's agents or em-

H. On-site Sales. All sales of tobacco products shall be conducted in-person in the licensed location. It shall be a violation of this chapter for any tobacco retailer or any of the tobacco retailer's agents or employees to engage in the delivery sale of tobacco products or to knowingly or recklessly sell provide tobacco products to any person that intends to engage in the delivery sale of the tobacco product in

the City.

I. Posting of Signs Every tobacco retailer post conspicushall ously in their place of business at each point of purchase a notice stating that the sale of tobacco products and cigarettes to persons under twenty-one years of age is prohibited by law and subject to pen alties. The notice shall also state that photo identification is required to purchase tobacco products. The letters of the sign shall be at least one-half inch in height.

- E. Proximity to other tobacco retailers. No newly established business requesting to be licensed for the sale of tobacco may be within 1,000 feet of a tobacco retailer location already licensed pursuant to this chapter as measured by a straight line from the nearest point of the property line of the parcel on which the applicant's business is located to the nearest point of the property line of the parcel on which an existing licensee's business is located.
- F. Proximity to cannabis retailers. No new license may be issued to authorize tobacco retailing within 1,000 feet of an existing cannabis retailer as measured by a straight line from the nearest point of the property line of the parcel on which the applicant's business is located to the nearest point of the property line of the parcel on which an existing cannabis retailer is loc-
- G. Measure of distance. The distance between any tobacco retail store and any school, playground, re creation center or facility, childcare center. library, or other tobacco retailer, or cannabis retailer, shall be measured in a straight line, without regard to intervening structures. from the exterior of the tobacco retail store to the closest property line of the school, play ground, recreation center or facility, childcare center, or library.
- H. Maximum number of licenses. The issuing of tobacco retailer licenses is limited as follows:
- 1. The total number of tobacco retailer licenses within the city shall be limited to 54.

 2. No new license may be issued to authorize tobacco retailing if the number of tobacco retailer licenses already issued equals or exceeds the total number authorized pursuant to subsection (1)
- I. Existing retailers. A tobacco retailer operating lawfully on the date

this ordinance is adopted may receive an exemption from Subsection D, E, F, and H, as long as all of the following conditions are met:

1. the license is timely obtained and is renewed without lapse or revocation;

- J. Change of business dispute. If the City de termines that a tobacco retailer has substantially changed their business premises or operation and the tobacco retailer disputes this determination the Tobacco Retailer bears the burden of proving by a preponderance of evidence that such change(s) do not constitute a substantia change.
- Section 9.38.050 Restrictions on location of tobacco products and tobacco advertising displays.
- A. It is unlawful for any tobacco retailer to place, maintain or cause to be placed or maintained any tobacco product or tobacco advertising display within two feet or any candy, snack, or non-alcoholic beverage display inside a tobacco retail store located within one thousand feet (1,000) or any youth-oriented facility.
- B. Except as allowed ir subsection A, it is unlawful for any person to advertise tobacco products within one thousand feet (1,000) of any youth-oriented facility.
- C. Subsection A does not apply to commercial establishments where access to the premises by persons under twenty-one years of age is prohibited by law.

Section 9.38.060 Sale of flavored tobacco products prohibited

Section 9.38.070 Tobacco product pricing and packaging

- . Packaging and la beling. No tobacco re-tailer shall sell any tobacco product to any consumer unless the tobacco product: (1) is sold in the manufacturer's packaging inten-ded for sale to consumers: (2) conforms to all applicable feder al labeling requirements; and (3) conforms to all applicable child-resistant packaging requirements Upon request by the City, a licensee must provide a copy of the certificate of compli-ance or full laboratory testing report for the packaging used.
- B. Display of price. The price of each tobaccc product offered for sale shall be clearly and conspicuously displayed on the tobaccc product or on any related shelving, posting advertising, or display at the location where the item is sold or

offered for sale.

- C. Distribution of tobacco samples or promotional items. It is unlawful for any person to distribute free or nominally priced tobacco products.

- 2. sell any tobaccc product to a consumer through a multiple-package discount or otherwise provide any such product to a consumer for less than the full retail price in consideration for the purchase of any tobaccc product or any other item; or
- 3. provide any free or discounted item to a consumer in consideration for the purchase or any tobacco product.
- E. Prohibition on the sale of individual cigar ettes. No tobacco retailer shall sell cigarettes individually or ir packages containing less than 20 cigarettes

Section 9.38.080 License application procedure.

- A. An application for a tobacco retailer's license shall be submitted in the name of each proprietor proposing to conduct retail tobacco sales and shall be signed by each proprietor or an authorized agent thereof. All applications shall be submitted on a form supplied by the Department.

A license issuec contrary to this Chapter, contrary to any other law, or on the basis of false or misleading information shall be revoked pursuant to this Chapter Nothing in this Chapter shall be construed to vest in any person obtaining and maintaining a tobacco retailer's license any status or right to act as a tobacco retailer in contravention of any provi sion of law.
- C. Applicant submissions must contain the following information:

Each tobacco re tailer will apply for the renewal of their tobacco retailer's license and submit the license fee no later than thirty (30) days prior to expir ation of the current license. A retailer that fails to timely submit a renewal application and fee is ineligible for license renewal and must submit a new anplication pursuant to this Chapter.

Section 9.38.110 Licenses not transferrable, past violations at retail location.

- A. Licenses not transferrable. A tobacco retailer's license may not be transferred from one Person to another or from one location to another. A new tobacco retailer's license is required whenever a tobacco retailer has a new tobacco retailing location or a location has a change in proprietors.

Notice and appeal of the revocation shall be conducted in accordance with this section.

F. If a license issued

under this chapter is suspended or revoked, all tobacco products at the suspended or revoked tobacco retailer's location shall be removed from public view for the duration of the suspension or revocation. The tobacco retailer additionally shall not display any advertise-ment relating to tobacco products that promotes the sale or distribution of such products from the tobacco retailer's location or that could lead a reasonable consumer to believe that such products can be obtained at that location for the duration of the suspension or revoca-

Section 9.38.160 Violations and penalties.

- A. Any licensee who is found to be in violation of this Ordinance, whether such violation is determined by a hearing officer or superior court; or the Licensee has pleaded guilty, "no contest," or its equivalent, or admitted to a violation, will be charged an administrative fine and as well as their license suspended or revoked follows:
- 1. Upon a finding by the Department of a first violation of this chapter at a location, the Licensee shall be issued a warning.

- D. All tobacco retailers are responsible for the actions of their employees relating to the sale offer to sell, and furnishing of tobacco products at the retailocation. The sale of any tobacco product shall be considered an act of the tobacco re-
- E. Tobacco products offered for sale in violation of this Chapter are subject to seizure by the Department or its designee and shall be forfeited after the li-censee or any other owner of the tobaccc products seized is given reasonable notice and an opportunity to demonstrate that the tobacco products were not offered for sale in violation of this Chapter. The decision by the Department may be appealed pursuant to the procedures set forth in Section 9.38.150. Forfeited to-

pacco products shall be destroyed and properly disposed of at the cost of the seller after all internal appeals nave been exhausted and the time in which to seek judicial review oursuant to California Code of Civil Procedare section 1094.6 or other applicable law nas expired without the iling of a lawsuit or, if such a suit is filed, after udgment in that suit becomes final.

F. Violations of this Chapter may, at the discretion of the City Attorney, be prosecited as infractions or misdemeanors when the interests of justice so require.

G. Violations of Chapter are hereby de-Violations of this clared to be públic nuisances.

H. In addition to other remedies provided by this Chapter or by other law, any violation of his Chapter may be 'emedied by a civil acion brought by City Atorney, including administrative or judicial nuisance abatement proceedings, civil code enforcement proceedngs, and suits for inunctive relief.

The remedies specified in this section are cumulative and in addiion to any other remedies available under State or local law for a violation of this Code.

Section 9.38.170 Exceptions.

Nothing in this Chapter prevents the provision of tobacco products to any person as part of an indigenous practice or a lawully recognized religious or spiritual ceremony or practice.
